

**DECLARATION OF CONSENT
AND MANDATORY APPLICATION FOR A SPORT PRACTICE**

declare with my signature my consent to take part in a sport practice at "Freiraum Arco Vienna Bogensportverein", ZVR 179823931 (hereafter the sports facility).

Training location: Praterstraße 9, Top 14

I am, resp. my legal representative is aware that when taking part at the aforementioned sports practice, my physical integrity may be compromised – including by an infection by SARS-CoV-2. I have evaluated this risk and accept it expressly by taking part at the sports training. Furthermore, I waive any claims towards the operator/s of the sports facility or the training organizer/s in case of an infection, as long as they have not acted deliberately or with gross negligence.

As a sport practitioner, I am aware that the aforementioned sports practice is conducted in compliance with the measures for containment of the Corona crisis, as stated in laws, regulation, guidelines and enactments, and confirm that I am aware of these statutory provisions. Furthermore, by entering the sports facility, for the entire duration of my visit, I am obliged to adhere to the statutory provisions, the House rules, the general rules of the Federal organization of the practiced sport, as well as all corona-relevant guidelines and recommendation of the relevant Federal sports organization, available at <https://www.oebsv.com>.

I am aware that the operator/s of the sports facility resp. the training organizer/s are allowed to enforce the adherence to the abovementioned rules. This includes the management of booking or access systems and records therein, as well as the commitment of security personnel. Furthermore, I am obliged to obey all instructions by the operator/s of the sports facility resp. the training organizer/s and their representatives with respect to adhering to the abovementioned rules. Non-compliance with these instructions can cause suspension from the training resp. expulsion from the sports facility. I am obliged to obey such a suspension or expulsion immediately and leave the premises.

I confirm, that to my knowledge I am not infected with SARS-CoV-2, nor have I been in any sort of contact with infected persons, nor have I been in an area at high risk of COVID-19 during the last 14 days before visiting the sports facility. Furthermore, I confirm that I am not, nor have I been in (house) quarantine because of such a contact or stay in such an area, nor do I belong to a risk group according to the provisions relevant to the containment of the Corona crisis.

In case of non-compliance with the COVID-19 regulation, resp. with the contents of this declaration of consent on my part, I am liable towards the operator/s of the sports facility or the training organizer/s. I expressly agree to indemnify and hold them harmless without exception in the event of claims by third parties based on a violation of this declaration of consent by my entering, my stay and/or my behavior on the sports facility for any reason.
